

2010 RULES AND REGULATIONS

Olentangy Rotary Club 9th annual Heart of Gold Charity Event

1. How to Enter: Upon receipt of payment for your ticket, you are entitled to one chance in a Raffle that will be held on February 13, 2010 in conjunction with the Olentangy Rotary Club 9th annual Heart of Gold Charity Event. Your name will be entered into a random, raffle drawing in which you will have one chance to win one of three major prizes. Entries into the major prize raffle must be received prior to the drawing scheduled to be held on February 13, 2010.
2. Except as provided below, all ticket sales are final. All tickets are non-refundable and non-transferable.
3. Eligibility: You must be 18 years old or older to participate. Members of the Olentangy Rotary Club and their families are eligible to participate. Ticket sales are void where prohibited by law. The Raffle is subject to the laws and regulations of the State of Ohio and all applicable federal, state and local tax laws.
4. Prize Drawing: Your odds of winning depend on the number of tickets sold, but in no event will they be greater than 1:1000. You need not be present at the drawing to win. If you win but are not present, you will be notified by telephone, mail and/or e-mail in accordance with the information provided by you on the ticket stub retained for the drawing. If you win a prize, you may, at the sole option of the sponsors, be required to verify your identity and/or your purchase of the winning ticket by producing the ticket itself, by executing an affidavit of eligibility, and/or by entering into a written liability release. Your failure to comply with these verification requirements within 14 days of notification shall void your ticket, and another ticket will be selected in its place.
5. **1st Prize consists of a cash prize of \$5,000.00.** This prize may not be reassigned and/or resold. The winner will be presented with a check that may be subject to tax withholding as governed by IRS regulations.
6. **2nd Prize consists of a 7 night stay at a Condo located in Hilton Head, SC.** Additional rules apply to the condo winner including, but not limited to: No Smoking, No Pets, Maximum 4 people with party being of age 25 or older, Refundable \$300 security deposit paid by the winner (refunded after stay if no damage), Winner must sign standard rental agreement (rent free). Winner responsible for coordinating dates with Condo representative and subject to availability and other scheduling limitations. Prize must be used within 2010. This prize may not be redeemed for cash, and may not be reassigned and/or resold.
7. **3rd Prize consists of 4 tickets in the Squire, Sanders & Dempsey suite at Nationwide Arena for a Columbus Blue Jackets 09-10 regular season game.** You will be responsible for coordinating the date and game with a representative of Squire Sanders, and your choice will be subject to availability and other scheduling limitations. You may be accompanied by a representative of Squire Sanders, and there may well be other persons and/or guests of Squire Sanders using the suite during the game you select. The tickets must be used by persons 18 years of age or older. You and your guests will be subject to all applicable rules and regulations of Nationwide Arena and its suite holders. This prize may not be redeemed for cash, and the tickets may not be resold by the prize winner.
8. As winner of any prize you will be issued a form suitable for filing with the Internal Revenue Service showing the value of the prize. Your acceptance of any prize in the Raffle also constitutes your consent to the use of your name, address, likeness and any statements made by you regarding the prize or the Raffle for advertising or publicity purposes without further compensation.
9. Cancellation of Raffle: The Raffle is sponsored by the Olentangy Rotary Club ("the Club"), an organization serving the community. Net proceeds of the event will be forwarded to the Olentangy Rotary Foundation that is managed by the Olentangy Rotary Club of Powell Ohio. The Club, however, reserves the right to cancel or reschedule the event and/or Raffle if sufficient tickets are not sold in advance. In the event of a cancellation, the purchase price of your ticket will be refunded in full to you at the address specified by you on the ticket stub retained for the drawing. If the Club elects to reschedule the Raffle, you will be notified, and the Club will, upon request, refund the purchase price of your ticket.

Release of Club and Observance of Rules. By purchasing this ticket and entering the Raffle, you agree to abide by these Rules. You also agree to release and hold harmless the Club, Rotary International, and/or their respective officers, directors, members and agents from any and all liabilities, claims or causes of action arising from the Raffle, including without limitation real or perceived flaws or problems relating to the raffle drawing process. The Club makes no warranties or other representations, express or implied, regarding the prizes, their safety or fitness for any use, or for the tax consequences, if any, of purchasing a ticket or winning a prize in the Raffle.
